The Warrick County Board of School Trustees met in regular session on July 11, 2022 at 7:00pm with all members present. President Mrs. Jane Wilhelmus called the meeting to order. A moment of silence was followed by the Pledge of Allegiance.

**Student Recognition**

### **Consideration of Items for Board Action**

- A. Mrs. Wilhelmus recessed the regularly scheduled board meeting in order to conduct a public hearing on the proposed Third Addendum to the Superintendent Contract. Notice of this public meeting was published in the *Boonville Standard* and on the school corporation's website. A copy of the proposed Third Addendum to the Superintendent Contract was also posted on the school corporation's website. No patrons came forward to provide comments on the same. The Board will consider action at the next meeting on July 25, 2022. The hearing was closed and the regularly scheduled board meeting reconvened.
- B. Dr. Lambert held the first reading of the revised Student Dress Code (policy 4010.) The revised policy, which has been approved by the Policy and Curriculum Committee, includes updates to some older language and follows current precedents. The second reading will take place at the board meeting on July 25, 2022 at which time the board may take action.
- C. A motion was made by Mrs. Gerhardt and seconded by Mrs. Glover to approve a purchase agreement between WCSC and Ray Allen for additional land near the construction site of Warrick Pathways and Career Center. Motion was carried.
- D. A motion was made by Mr. Tim Mosbey and seconded by Mr. Jeff Baker to approve a proposed agreement for a temporary and perpetual water line easement between WCSC and the City of Boonville. Motion was carried.
- E. A motion was made by Mrs. Brenda Metzger and seconded by Mrs. Glover to approve a contract between WCSC and Evansville Association for the Blind. The contract specifies that Evansville Association for the Blind will provide diagnostic and therapeutic services to WCSC students. Motion was carried.
- F. A motion was made by Mr. Baker and seconded by Mrs. Gerhardt to approve the 2022-2023 agenda books for all middle and high schools in the Corporation. There were minor changes made at the school level, which are highlighted in the documents shared in the board packet. The Policy and Curriculum Committee approved the books at its meeting on June 27 and sent them to the Board for final review and approval. Motion was carried.


With no further business, the meeting was adjourned.
