Consideration of Items for Board Action

A. At the Board Meeting on July 11, 2022, a Public Hearing was held for comment on the proposed Third Addendum to the Superintendent's Contract. The proposed addendum and contract were properly advertised and posted on the corporation website and in the

- Boonville Standard. A motion was made by Mrs. Glover and seconded by Mr. Jordan Aigner to approve the addendum as written. Motion was carried.
- B. A motion was made by Mrs. Glover and seconded by Mr. Aigner to authorize the superintendent to hire employees to ensure schools are fully staffed for the start of the school year. As positions are filled, the Board will be provided the names of the new hires and will take subsequent action at the next Board Meeting. Motion was carried.
- C. The second reading of the revised Student Dress Code Policy (4010) was conducted by Dr. Lambert. Following the reading, Mrs. Gerhardt made a motion which was seconded by Mrs. Glover to approve the revised policy as written. Motion was carried.
- D. A motion was made by Mrs. Gerhardt and seconded by Mr. Jeff Baker to adopt the proposed 2022-2023 student fees for the middle and high schools. Motion was carried.
- E. A motion was made by Mr. Tim Mosbey and seconded by Mrs. Gerhardt to approve an adjustment to the 2022-2023 school year calendar. In order to reach 182 contractual days, August 8 and May 25 were changed to full teacher workdays rather than half days. Administrators and Warrick County Teachers Association are already aware and supportive of this modification as it allows us to keep 16 days off at Christmas and two Professional Learning days. The adjustment pertains to certified teaching staff, nurses, program assistants, and any other employee who works 182 days. Motion was carried.
