The Warrick County Board of School Trustees met in regular session on October 24, 2022, at 7:00 pm with the following Board Members present: Mrs. Jane Wilhelmus, Mrs. Lynda Glover, Mr. Tim Mosbey, Mrs. Brenda Metzger, Mr. Jeff Baker, and Mr. Jordan Aigner. President Mrs. Jane Wilhelmus called the meeting to order. A moment of silence was followed by the Pledge of Allegiance.

Patron Concerns

Robert Howard came before the Board to comment on Tecumseh High School football record of 10-0. He encouraged all to attend the next game on Friday, October 28, 2022.

Public Hearing - Issuance of Bonds

Mrs. Wilhelmus recessed the regular Board of School Trustees meeting and opened a Public Hearing on the issuance of bonds. Notice of this public hearing was published in the Boonville Standard on October 13, 2022 and October 20, 2022 and posted on the School Corporation's website. Mrs. Wilhelmus opened the floor to the public for comment. With no discussion, Mrs. Wilhelmus closed the public hearing and reconvened the regular Board meeting.

Consideration of Items for Board Action

A. A motion was made by Mrs. Glover and seconded by Ms. Metzger to adopt the Additional Appropriation Resolution. The proceeds from this bond issue must be appropriated prior to being spent on the projects.

- **B.** A motion was made by Mr. Mosbey and seconded by Mr. Aigner to adopt the Final Bond Resolution. The Final Bond Resolution establishes the amount to be borrowed, maximum term of repayment and maximum interest rate. In addition, the resolution sets forth the form of the bond, authorizes the publication of the Notice of Intent to Sell Bonds and establishes the maximum cost an underwriter or bank may bid for the bonds; establishes a bid committee who will award the bonds to the lowest bidder; and approves the form of a document required by the Securities and Exchange Commission, in which the School Corporation agrees to annually provide certain types of financial information to the SEC and provide notice of certain material events on a timely basis. The School Corporation has entered into this type of agreement before.

 - \$500.00 from Old Friendship Church to benefit students in need
 - \$1,000,00 from Old Friendship Church to be used for students Christmas gifts
