# **Student Recognition**

Boonville High School Trap & Skeet Team introduced by Nicole Nurrenbern
The BHS Trap & Skeet Team are 1 of 5 teams currently in Southern Indiana. This includes the Trap & Skeet team at USI. In the fall season, there were 14 schools assigned to 4 conferences based on team size. There were 319 students in the league. The team won first place in their conference. Ryder Griswold won 2<sup>nd</sup> place male in Conference 3. Will Nurrenbern won 1<sup>st</sup> place in Conference 3 and won Season Average Overall and Season Average Male.

Below is the list of students that participated on the team this past fall. Ten of these students participated on both the Trap and Skeet teams. Overall, 11 students were in the top 25% of a total of 319 Trap students registered for this season. Of the 10 students that participated on the Skeet team, 3 of those students were in the top 50% of the 30 registered students for the season. Fall 2022, was their first season participating in Skeet. Spring registration starts on February 1, 2023 and is open to all students in grades 6 through 12.
