Recognition of the Spring State Finalist Athletes

Boonville High School track coaches, Mr. Jason Mayes and Mr. Tristan Selby, introduced the three state finalist athletes. The season ended breaking two long standing school records in the boys 4 by 800 meter and the girls 4 by 100 meter.

B. Tonight is the first reading of proposed *Policy 5350 - Prohibition of Wireless Devices During Instructional Time*. This new policy will allow Warrick County School Corporation to maintain compliance with Senate Enrolled Act 185, which was passed by the Indiana

General Assembly and signed into law on March 11, 2024. The second reading with a final vote on this policy will be Monday July 8, 2024.

- C. A motion was made by Mr. Baker and seconded by Mr. Franz to approve a Partnership Commitment between the Southwest Indiana Workforce Board, Inc. and the Warrick County School Corporation. This agreement will allow the Jobs for America's Graduates (JAG) program to implement their services within Boonville High School. Motion carried.
- D. A motion was made by Mr. Mosbey and seconded by Mrs. Glover to approve Change Order #1 for the 2024 Summer Renovations Project. This Change Order contains an addition of \$26,107 to remove the floor tile and asbestos-containing glue from the lower level gym floor at CHS as well as the structural Concrete Masonry Unit (CMU) wall bracing revisions per the open art room ceilings. The floor tile came back negative during asbestos testing, but the mastic adhesive was found to have asbestos creating the necessity to remove the floor rather than laying new flooring on top of the old floor. The structural steel revisions are necessary to accommodate the open ceiling design for the new art room.

- **E.** A motion was made by Mrs. Glover and seconded by Mr. Baker to approve Change Order #3 for the CHS/BHS turf project that adds the installation of turf at CHS baseball field. The change order total is \$399,999.
