The Warrick County Board of School Trustees met in regular session on July 8, 2024, at 7:00 pm with the following Board Members present: Mr. Eric Franz, Mr. Tim Mosbey, Ms. Brenda Metzger, Mr. Jordan Aigner, Mr. Jeff Baker, and Mrs. Jane Wilhelmus. Board Member not present, Mrs. Lynda Glover. YouTube is the electronic means of communication used by the public to attend remotely.

President Wilhelmus called the meeting to order. A moment of silence was followed by the Pledge of Allegiance.

Recognition of spring State Finalist Athletes

Coach Gordon Wood recognized the 2023-2024 Tecumseh High School Softball Team and their accomplishments:

- Record this year 24-10
- 6-0 vs 2A schools
- 9-2 vs 3A schools
- 4-7 vs 4A schools
- Conference 10-1, THS was the only 1A school in the conference
- 4 THS Players made All State and All Conference
- 2 THS Players played in the Senior All Star Game. Jenna Donahue was named Miss Softball at the All Star game (out of 85 schools)
- 3rd year in a row THS made it to the State Championship Game (Won in 2022 & 2023)
- Next Year THS will be moved to 2A by the IHSAA

Consideration of Items for Board Action

A. Policy 5350 - Prohibition of Wireless Devices During Instructional Time will allow Warrick County School Corporation to maintain compliance with Senate Enrolled Act 185, which was passed by the Indiana General Assembly and signed into law on March 11, 2024. The first reading of this proposed policy was on June 24, 2024. Following the second reading tonight, a motion was made by Mr. Baker and seconded by Mr. Franz to approve the policy as written.

Motion carried.

- **B.** A motion was made by Ms. Metzger and seconded by Mr. Baker to approve the School Calendar for the 2025-2026 academic year. This calendar has been created and reviewed by administration, WCTA, and principals. The first day of school for students is on August 6, 2025 and the last day for students is on May 20, 2026. The motion passed unanimously, with five aye and one nay.
- C. A motion was made by Mr. Aigner and seconded by Mr. Mosbey to approve the bid for HVAC equipment installation at four schools (CHS, BHS, CSMS, and Newburgh Elementary) to Deig Brothers. Warrick County School Corporation ordered the equipment to be installed several months ago directly from the manufacturers, and the shipping timelines ranged from June to December of 2024. The work included in this bid will be completed as timely as delivery and school operation will allow. Motion carried.
